The Prince's Charities Australia is the coordinating presence for His Royal Highness The Prince of Wales' Australian charitable interests.



A considerable area of charitable interest for His Royal Highness is the welfare of Australian Defence Force members and their families.

With this in mind, The Prince's Charities Australia designed a business training program specifically for Defence members transitioning, or recently transitioned, from full time military service.

The Prince's Lead Your Own Business program (PLYOB) takes place over an 18-month period with participants attaining a nationally recognised qualification in small business management upon completion of the program. The education component of the program is facilitated by RMIT University - an institution renowned for its business education.

The course work incorporates a business proposal, online learning and assessments, an intensive residential at RMIT University in Melbourne, and personalised mentoring from industry experts that extends for 12 months.

PLYOB's bespoke approach also considers the unique sensitivities that active military service can incur and includes support services for participants where required. His Royal Highness has remained highly engaged in the program since taking an interest in its design. He provided a personalised video message of support to the 2015 program participants, which was played at the opening dinner event to launch the residential week in June.

Several of the program participants have corresponded with His Royal Highness and many were able to meet him during His Australian tour in November to personally speak with him about their business's progress.

Support for the program is widespread, including a personal endorsement from Air Chief Marshal Mark Binskin AC, Chief of the Defence Force, and a number of organisations and philanthropists offering scholarships for individual participants.

The generous support of principal sponsor, Dr Haruhisa Handa of the World Wide Support for Development (WSD) organisation and corporate partners Defence Housing Australia and the Commonwealth Bank, is greatly appreciated by The Prince's Charities Australia and program participants.

Already the 2015 cohort have achieved significant milestones with Captain Shaun Fisk winning the "Best Maritime Innovation" award at the recent "Pacific 2015 International Maritime Exposition, Major Cherisa Bellis securing her first major contract for her business Major Freedom and Brad Barr recently being granted a \$25,000 interest-free loan from RMIT's New Enterprise Investment Fund.

The entire 2015 program cohort will graduate by March 2016, with all participants providing feedback that they would recommend the program to fellow transitioning Defence members.

As a result of the highly successful pilot program, PLYOB will grow next year to include 25 participants. Applications for the 2016 program opened in November this year with enrolments to commence in April 2016.

# **Psychological Recovery following Community Disaster: An International Collaboration**

In partnership with Phoenix Australia - Centre for Posttraumatic Mental Health, The Prince's Charities Australia facilitated an international roundtable of mental health experts to establish a world-first protocol addressing post-disaster mental health.

The mental health effects of trauma and disaster generate major economic, health, and well-being challenges around the world. The increase of adverse weather conditions and terrorism related-disasters has brought this issue into sharp focus, with governments and health services keen to provide the best possible care for those affected. While most physical injuries heal, the unseen psychological scars can last a lifetime and cause distress and reduced functioning not only of the survivor, but also their loved ones.

The roundtable, which took place over two days in November, involved the development and evaluation of an internationally agreed protocol, which would assist individuals to overcome the mental health impacts of natural and man-made disasters in both an immediate and long term capacity.

A core group of 21 internationally leading mental health experts from the US, UK, Canada, Australia and the Asian region arrived at a consensus regarding the nature of the optimum intervention and a methodology to trial its effectiveness. Their presence at the meeting in Sydney is testament to the high priority of this issue across the world. More importantly, the commitment shown by these experts to continue working on and promoting the project speaks powerfully to the likelihood of long term success.

His Royal Highness attended the official opening of the event in Sydney to meet with roundtable participants as well as Defence members, emergency services personnel, and other first-line responders to disaster situations who would implement the roundtable's protocol.

Over the two days, the core group of 21 agreed on the goals of the intervention, the target population for the intervention, the structure and the content, including a mix of strategies with an emphasis on reducing distress, enhancing and looking after social supports, and identifying and activating value driven behaviours.

The international consortium in now focused on the next stages of the framework development including the creation of delivery manuals and an evaluation methodology to test the framework in community.

The primary goal of this process is to reduce distress and disability in people and their families affected by trauma. The potential savings, both economically and in terms of human suffering, are enormous. This can only be achieved through an international collaborative approach to design and evaluate the intervention - we need to know what works, and for whom, before recommending the framework for an international rollout.

# The Prince's Terrace Adelaide

A collaborative project between Defence Housing Australia (DHA), South Australian Government and The Prince's Foundation for Building Community (based in the UK), the The Prince's Terrace Adelaide project will construct 12 homes, all designed with the local environment, sustainability and the maintenance of community in mind. The joint venture is the first Australian development for The Prince's Foundation, helping to raise the awareness level and viability of sustainable residential developments, workplaces and communities.

The homes will be the first residential development in Australia to attain a '6 Star Green Star' sustainability rating - a great achievement and a real demonstration project of what can be achieved with strong partnerships and thoughtful design.

Located in the Bowden urban renewal precinct, the 8 house terrace and 4 mews apartment development features sustainable measures including local, low-carbon materials in the construction, locally sourced concrete made with fly ash, local granite and bricks re-used from old Bowden industrial buildings, as well as:

- Ceiling fans to control the indoor climate, complemented with small but high efficiency air conditioning systems for peak Adelaide temperatures;
- LED lighting and photovoltaic solar panels generating renewable energy to reduce the building's peak power demand; and

· High efficiency water fittings, with toilets and laundry fittings supplied with 100 per cent recycled water.

These features are expected to cut energy and potable water use by more than 50 per cent, and carbon emissions by more than 40 per cent compared with a typical house.

• The Adelaide demonstration build will be supported with a knowledge transfer program providing Training and education on sustainable building practices as well as materials and workshops to equip professionals, graduates and students with the skills they need to design, build and preserve sustainable urban environments.

During H.R.H.'s visit in November, The Prince of Wales turned the first sod on the construction project. Construction is now underway and is due to be completed in the second half of 2016.



# 'Encounters' Indigenous Scholarship Program

In line with His Royal Highness' commitment to preserving Indigenous culture, The Prince's Charities Australia, the National Museum of Australia (NMA) and and The Prince's School of Traditional Arts forged a partnership to create a scholarship program for regional and remote Indigenous and Torres Strait Islander community cultural workers to undertake professional development.

The collaboration will link the Museum's expertise in cultural documentation, preservation, research and communication to The Prince's School of Traditional Arts' strengths in the teaching of traditional arts and crafts with an understanding of the philosophy inherent within them.

The Encounters Indigenous Scholarship Program was developed in response to a call for community cultural training by NMA's Indigenous Reference Group (IRG) as a legacy following the extensive stakeholder consultation process undertaken by the museum during the development of the Encounters exhibition. The Encounters exhibition features some of the oldest artifacts collected from Aboriginal and Torres Strait Islander people along with contemporary Indigenous Australian works.

The initial pilot scholarship program will provide for six young cultural workers from Aboriginal and Torres Strait Islander communities to undergo an intensive three-month program in both Australia and United Kingdom.

The London components of the scholarship program will include time at The Prince's School of Traditional Arts, extended visits to the British Museum and Oxford and Cambridge Universities. In addition to the training, the scholarship will provide participants with a stipend and all accommodation and travel costs.

Participants will develop skills and knowledge over a diverse range of professional practices including exhibition development, collection practices, research and digital integration. The program will also help to connect international organisations with remote art centres and local organisations, with a view to future cooperative ventures.

At the beginning of their scholarship program, participants will be asked to identify a particular cultural challenge for their community, which they will work to address through their experiences and learning. By the end of the program, they will have developed strategies and an action plan for implementing when they return to their community.

The scholarships were announced following a visit to the Museum by His Royal Highness in November.

The Prince of Wales is Patron of both of the Encounters Exhibitions at the British Museum and the NMA.

Seeing is Believing is a program originally developed by Business in the Community, one of His Royal Highness' UK Charities. The program aims to close the gap between the boardroom and the community by taking senior business leaders into the heart of communities to assess how their businesses can make a positive impact.

The UK program is a resounding success and has been operating since 1990. More than 9,000 senior business people have visited communities across the UK developing a deep engagement with local people and a better understanding of the issues they face.

In partnership with the Australian Business and Community Network (ABCN) – an organisation that pairs businesses with schools to improve educational outcomes for students - The Prince's Charities designed a tailored Australian version of Seeing is Believing. Over 20 senior business leaders took a day out of their schedules to visit three schools in Geelong, Victoria. Participating organisations included companies such as Bendigo and Adelaide Bank,

Jetstar, Optus, PwC, Bain & Company, Navitas, TAC, National Disability Insurance Agency, WorkSafe, and Hall & Wilcox.

As part of the visit, participants were briefed by school staff on the challenges faced by students and their families before entering the classroom to meet the students themselves and gain a personal view of their daily activities.

Following the visit, participants undertook a facilitated workshop to discuss their understanding of the challenges faced by the school communities, and how their business networks and resources could be of use to the schools and their communities.

Strategies will be developed in individual consultation with each participant in the coming months, and we look forward to bringing you news of the outcomes.

The program was profiled on ABC News Victoria in November.

EON Foundation Inc. (EON) is a West Australian-based not for profit organisation that engages with remote Indigenous schools and communities in a long term capacity to construct and maintain edible gardens, and deliver a program encompassing gardening, nutrition education, cooking and hygiene.

EON was founded in 2005 as a food and nutrition focused healthy lifestyle and disease prevention program in Indigenous communities. Its 'Thriving Communities' program was specifically developed to address poor health conditions and subsequent negative impacts on education outcomes for Indigenous children, particularly in remote communities.

The Thriving Communities program is implemented in communities over five years, with an EON staff member working in the community every fortnight, assisting to build trust and deepen EON's engagement and sustainability of the program in each community. The program is now established across 17 communities in Western Australia.

The Prince's Charities Australia is partnering with EON as a supporter, and an advocate to help raise awareness of the impactful work carried out by EON as it seeks to raise funds to ensure its ability to work with more communities to address the disparity of health outcomes in these remote communities compared to the rest of Australia.

This year EON celebrated its 10th birthday by welcoming Federal Health Minister Sussan Ley to tour La Grange Community School and the edible garden it developed.

There are some 20 communities on the waiting list for engagement with the EON. With further financial support, the organisation is well positioned to meet this need and expand its services into a greater range of communities across Australia.

# **Trustees and supporters tour** His Royal Highness's rejuvenated **Dumfries House**

The Prince's Charities Australia Trustees and supporters visited Dumfries House, Scotland, for a tour and private dinner with His Royal Highness. Dumfries House, built between 1754 and 1759, is set in 2,000 acres of land near Cumnock and is acknowledged as one of the most architecturally significant stately homes in the UK.

In his capacity as Great Steward of Scotland's Dumfries House Trust, H.R.H. headed a consortium of charities and heritage bodies which bought the house and its land in 2007. The purchase prevented the house, contents and estate from being broken up and lost to the nation. Dumfries House was opened to the public for the first time in 250 years in 2008. It is now operating as a tourist attraction, education and training centre and has helped to regenerate the local economy in East Ayrshire.

The Prince's Charities Australia Trustees and supporters who attended the event were able to see first-hand the impact of "place-based" sustainable business and community development.

# Dame Julia Cleverdon visits -**April and October**

The Prince's Charities Australia was delighted to welcome Dame Julia Cleverdon DCVO CBE on two occasions in 2015. Vice President of Business in the Community and Special Adviser to The Prince's Charities, Dame Julia engaged with Australian philanthropists, business leaders and charitable organisations during visits in April and October.

During her October visit, Dame Julia played an important role in meeting with three Geelong schools in preparation for the implementation of our Seeing is Believing program in their communities.

### **Tony Beddison AO**
